PAYMENTS - For Peak to Peak Travel Trips, payments are generally made by credit cards, personal checks/travellers checks or money orders in US Dollars. We also accept bank drafts in US Dollars. A deposit secures your booking and full payment is due 90 days prior to the start date for your trip. The balance of payment must be through one of the methods mentioned above. We will send you receipts for all payments. All prices are subject to change.

CANCELLATIONS - Once you have paid your deposit your trip is confirmed, subject to payment of the balance of fees owing 90 days prior to your trip commencement date.

- Cancellations outside of 90 days will result in the loss of the trip deposit.
- For cancellations made within 60-89 days of the trip commencement date we reserve the right to retain 50% full fee.
- For cancellations within 45-60 days of the departure date a cancellation fee of 70% of the full fee applies.
- For cancellations within 45 days of the departure date a cancellation fee of the full fee applies.
- We strongly recommend trip cancellation insurance from your insurance company.

Peak to Peak Travel reserves the right to change the route, departure date or conclusion date of the trip due to inclement weather, animal health, and political situation or for any other reason. In the event of route changes, changes in the duration of the trip, date changes, postponement, injury, loss or damage the trekker has no right of compensation or refund of payments made (in part or in full).

Neither Peak to Peak Travel nor the trekker shall be liable for a failure to perform any of its obligations arising from this agreement if such failure is due to an unavoidable or unpredictable event, which is out of the control of Peak To Peak Travel and the trekker, which came into force after the date of this agreement being signed.
